<u>ELIGIBILITY TO PARTICIPATE.</u> Participants must be over the age of 18 and a resident of one of the 50 United States or DC, to participate. EACH PARTICIPANT WILL BE REQUIRED TO EXECUTE THIS RELEASE, HOLD HARMLESS AND INDEMNITY AGREEMENT PRIOR TO PARTICIPATION IN THE CONTEST TO BE ELIGIBLE TO PARTICIPATE.

<u>CONTEST RULES</u>. Participants individually or in conjunction with their respective team members must eat seven large meats, two Rolls, and three large sides in one hour or less. Participants will be timed by a Crossbuck employee or team member. Participants must follow the following rules:

- 2) Who can compete: Participants or a team of 2-4 Participants to be designated at the beginning of the Challenge.
